The Performance Rights vested on 2/27/13, based upon the Compensation Committee's determination that the applicable performance criteria had been met as of 2/2/13. 2,589.75 shares vested of which 108 shares were withheld for taxes. The reporting party elected to defer the balance of 2,481.75 shares to the Executive Deferred Compensation Plan.
- 2. Includes 537 shares acquired on March 31, 2012 and 101 shares acquired on September 30, 2012 under the Employee Stock Purchase Plan.
- 3. Exercise of tax withholding right upon settlement of Performance Shares. The tax withholding right was previously approved by the Board's Compensation Committee at the time of the Performance Share grant.
